If you cancel after the 10 th of March, 2025 :
  - With the GRITCHEN cancellation/repatriation insurance you will be compensated according to the conditions of contact No. 6181 (see below) ;
  - Without the GRITCHEN cancellation/repatriation insurance you will possibly be reimbursed according to the current conditions, that is, the sum that we can recover from our hosts, minus a fee of €50.

### **CANCELLATION/REPATRIATION GUARANTEES**

**Code du Tourisme Article R211-4** (Decret n°2009-1650 du 23 decembre 2009) à l'alinéa 12 :

*12° Information concerning the optional subscription of an insurance contract covering the consequences of certain cancellation cases or of a contract of assistance covering certain special risks, notably the costs of repatriation in the case of an accident or illness.*

### **Guarantee Cancellation - Interruption - Extension COVID Contrat n° 6181**

If you cancel for any other reason, you will eventually be reimbursed according to the current conditions, that is, the sum that we can recoup from our hosts, minus €50.
